## Funeral Director Only Reciprocity Application

Before an individual from another state, seeking reciprocity for a funeral director only license, must take and pass the West Virginia Laws, Rules and Regulations (WV LRR) examination before a license can be issued. Please submit, along with this application, a copy of your degree and state license from all states you are licensed in. **DO NOT SUBMIT PAYMENT FOR THE LICENSE WITH THIS APPLICATION**. Once we receive the Funeral Director application, we will send you an application for the WV LRR exam to be completed and returned with payment for the exam. After successfully passing the exam, you will qualify for a Funeral Director's license, and this is when you will send the payment for the license.

You must also meet the two (2) year apprenticeship requirement. For reciprocity, this can be met by one of the following ways:

- 1. Serve an apprenticeship under supervision in the state you're licensed in for two
- (2) years; or
- 2. Serve a one year apprenticeship and have a valid state license for one (1) year.
